Re: Manufacturer Certification, MIL-PRF-19500R, FSC 5961, VQ (VQE-23-037904), CAGE Code: 31757, Control Number: 084584

Your facilities located at 1655 Highway 66, and 905 E. Walnut Street, Garland Texas were audited by Messrs. Brad Deslich and Lorenzo Best of this Center, Mr. Benny Damron of NASA/Jacobs Engineering, and Mr. Russ Quakenbush of NAVY Crane on March 20-23, 2023 for compliance with the Manufacturer's Certification requirements of MIL-PRF-19500R. All deficiencies found during the audit are now closed.

Compliance with these requirements has been successfully demonstrated; therefore, Micropac Industries Inc. is considered a certified manufacturer eligible to qualify and supply JAN, JANTX, and JANTXV optically coupled isolators and LED's in surface mount, "TO" can packages, ceramic packages, and panel mount assemblies in accordance with the requirements of MIL-PRF-19500R.

All wafer fabrication is to be performed at 905 E Walnut Street facility. All assembly is to be performed at the 1655 Highway 66 facility or at your contracted Juarez, Mexico facility (JAN and JANTX). All qualification tests, conformance inspections, and screening must be performed at facilities that have DLA Land and Maritime –VQE Laboratory Suitability Status for each of the applicable test methods.

This certification will normally be valid for two years from the date of this letter and can only be terminated by written notification from this Center. For the duration of the certification, the manufacturer is subject to periodic reviews by the qualifying activity or its representatives. Certification will not normally be extended beyond the two-year period without a re-audit.

Note: The results of the DLA-VQE audit held on March 20-23, 2023 were found by examining a sampling of the manufacturer's normal manufacturing, and processing procedures. The acceptance of the corrective actions from the above referenced audit does not relieve the manufacturer of its contractual obligation to deliver product that complies with all specification requirements. Manufacturers are required to inform this office immediately after learning of a GIDEP alert, problem advisory, or other notification on their QML product.
